Barbara DiCicco-Bloom RN PhD, is Director of the Health Services Research Fellowship in the Department of Family Medicine, UMDNJ-Robert Wood Johnson Medical School. She practiced home care and hospice nursing for 27 years and has been a health services researcher for 25 years. Her research interests include critical and feminist theory and have been applied to the study of care of culturally diverse patients, the experiences of immigrant nurses, and more recently, the relationships of nurses and physicians in primary care settings. She was a Co-Investigator on a five-year practice-randomized clinical trial funded by the National Heart, Lung, & Blood Institute and Principle Investigator for a National Institute of Nursing Research small grant to study social capital among nurses and physicians in primary care practices in relation to patient outcomes.

Dr. DiCicco-Bloom is a mixed methods researcher with expertise in both qualitative and quantitative methodologies with specific expertise in the design, conduct, and analysis of in-depth interviews.
